



Renamed options on Spectrum Super

IOOF is moving to a single multi-manager offering in order to achieve a simple and efficient investment model across the IOOF group. As a result, the United Funds will no longer be offered to investors and the IOOF MultiMix Trusts will take their place.

Many of the United Funds are available through Spectrum Super. While this won't impact your account greatly, you will see changes to the names of some of the investment options available on the Spectrum Super menu.

Name changes

The following options available on the Spectrum Super menu will be renamed.

Minimal impact

If you're invested in Spectrum Super, the impact of these changes will be minimal because you're invested through a Master Pooled Superannuation Trust (MPST), not in the underlying funds themselves. The MPST invests in the underlying funds on your behalf and therefore the MPST will manage the transition from the United Funds to the MultiMix Trusts.

Importantly, there will be no buying or selling of assets within your account. You will remain invested in the same pools through the same MPST after the transition. You will, however, see the name changes outlined above. The names of the pools within the MPST will be changed from United to IOOF MultiMix.

These changes will take effect on 30 September 2011.

Ongoing investment instructions

There will be no impact on your ongoing investment instructions (such as regular savings plans and distribution instructions) because you will remain invested in the same pools through the same MPST.
